



DECISION OF THE CONSORCIO DE LA CIUDAD DE SANTIAGO DE COMPOSTELA GRANTING TO EXTEND THE REGISTRATION PERIOD FOR THE ADVANCED COURSE IN ORCHESTRAL SPECIALIZATION OF ESCOLA DE ALTOS ESTUDIOS MÚSICALES (EAEM) AND POSTPONE THEIR TESTS FOR THE DAYS 14,15,16,17 AND 18 SEPTEMBER 2020

Background

On 16 December, 2019, the Board of Directors of the Consorcio de la ciudad de Santiago de Compostela approved the call for applications and the selection rules of students from the Advanced Course of Orchestral Specialization for year 2020-2021, after a favourable report by the State's legal counsel dated 13 December 2019.

On 10 February, 2020 these rules were published in the BOP (Official Provincial Gazette) of the province of A Coruña.

The rules established a registration period that ended on 28 May, and the dates were set from 6 to 11 July to carry out the on-site tests at the headquarters of the Escola de Altos Estudios Musicales in Santiago de Compostela.

On 14 March 2020, Royal Decree 463/2020 of 14 March was published in the BOE (Official State Gazette) and came into force declaring the State of Alarm for the management of the health crisis situation caused by COVID-19, which provided in its third additional provision, paragraph 1, that the terms were cancelled and the deadlines for the processing of public sector entities were interrupted. The calculation of the deadlines will be resumed when this royal decree or, where appropriate, any extensions thereof ceases to be in force.

On 23 May, 2020, the Decision of 20 May, 2020 of the Congress of Deputies was published in the BOE ordering the publication of the of authorization agreement of the extension of the state of alarm declared by the Royal Decree 463/2020 of 14 March, which provides in paragraph 10 that with effect from 1 June 2020, the third additional provision of the Royal Decree 463/2020 of 14 March on the cancellation of administrative deadlines will be repealed. From that date, the calculation of the periods that would have been cancelled shall be resumed, or restarted, if provided for in a rule with the status of a law approved during the validity of the state of alarm and its extensions.

Although the registration process, when carried out telematically through the EAEM's website, was never interrupted, it is appropriate, in any case, to give compliance with the above mentioned precepts to ensure legal certainty of person interested in the process.

As a result, it is also necessary to postpone the dates planned for the holding of the selection tests originally scheduled for 6 to 11 July.
